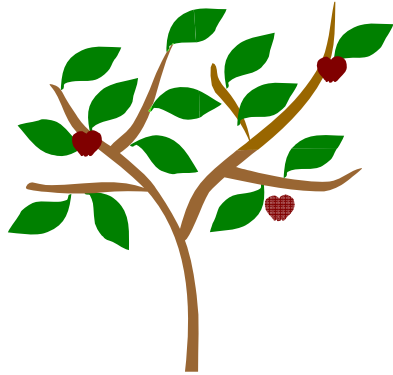

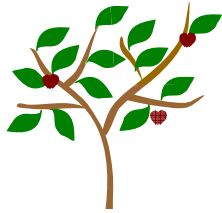

We are currently seeking accreditation with the Association of Christian Schools International. We have reached candidacy status and will be seeking full-accreditation within the next two years. Our school will benefit from this accreditation in many ways including, but not limited to enhanced biblical foundation and moral teachings, increased preparedness in all academic disciplines, improved extra-curricular programs, a well-defined school structure, and place of our school within a network of other accredited schools.

School Beliefs

Mission

Our school mission is to provide a quality Christian education to all children. We desire all children to know God's love. With a Christian foundation, leadership development, and academic excellence, our students will reach their highest potential.

Vision Statement

Our school has a vision of growing as a leading Christian school that equips students with a solid biblical foundation. Our intent is to follow God's direction and grow our program in a way that glorifies Him. Our goal is to offer preschool and a K-12 academic institution that will serve the children within our community.

Philosophy

We desire to reach out to all children, regardless of their faith, to teach them about Jesus Christ and experience a life filled with His love. The love of Christ is shown to each child and can be witnessed in all aspects of their educational-and social experiences. Each student in our school is treated as an individual and met at their academic and spiritual level.

Winchester Academy is committed to providing a non-denominational foundation of Christian truths and values without integrating doctrine specific to any one denomination. This school is part of the body of Christ; therefore, it guides its students to find his or her special place in the body of Christ. As an educational institution it is our intent to guide students to discover and grow in this place.

We are committed to fostering the developmental needs of our children through a rigorous curriculum, within a loving and nurturing environment that is based upon a Christian foundation. We recognize that all children develop at different rates, and we will teach to these individual needs. Winchester Academy has high expectations for all students, in accordance with the belief that all children can learn. Challenging material is presented and teachers assess understanding using a variety of methods.

At the preschool level, objectives in the areas of social/emotional, mathematics, language, and gross/fine motor skills have been developed through a hands-on, developmentally appropriate curriculum. It is the intention of the school to expose preschool children to enriching learning experiences by providing them opportunities for growth in each of the objective areas.

At the elementary level, the Virginia Standards of Learning are used as a baseline for all subject areas. Curriculum is focused on engaging the student in the academic process with an effort to encourage them to become lifelong learners. Our nurturing teachers focus on building an academic foundation that encourages children to take risks.

At the middle school level, the Virginia Standards of Learning are the academic baseline for all subject areas. The program fosters students academically, physically, emotionally, and spiritually through a challenging student-centered curriculum and varied enrichment programs, provided by a motivated team of creative professionals.

We encourage all of our students, regardless of their age or grade, to appreciate art and music, begin to learn a second language, and be exposed to up-to-date technology through computer use. We believe that this exposure will help them to become positive and productive members of our diverse society. We emphasize the importance of self-discipline, respect for others, and development of self-concept, through Christian values. We teach the essential skills of problem-solving, critical thinking, and peer interaction, which better prepares them for the life-long learning process. With the support of our parents and the community, we help our children to understand God's grace through our example.

Core Values

The following core values are the convictions that support and empower the purpose of Winchester Academy. They provide the school with security and ultimately shape its moral culture.

Biblical Integration

Biblical integration of every planned learning experience is critical in developing an educated citizen with a Biblical world view. Each student will learn to defend their faith and to live a lifestyle in accordance with it. The Bible is essential to our curriculum program and taught at every academic level.

Character Development

Character development based on the Word of God is instilled in the hearts of all students. Every child receives individual discipleship in self-discipline and personal responsibility in an orderly environment of Christian love and compassion. Each student will be trained to be a leader as he/she is given opportunities to lead others. Individual gifts and abilities will be fostered and supported.

Compassion for Others

Students are taught to love God with all their heart, soul, mind, and strength, and to love their neighbors as themselves. As students grow in their relationship with God, they will glorify Him through their interactions with others. A student's relationships with fellow students, parents, and teachers will be one that shows respect, is Christ-centered, and edifying.

Academic Excellence

Winchester Academy is committed to an academic program that will prepare our students for higher education. High academic standards are maintained for all students with the expectation that each child can succeed. Every child is encouraged to maximize his/her learning potential and to develop a lifelong love for learning. Students will be equipped with a high-quality education to influence the world for Christ. Critical thinking skills and hands-on learning experiences will be used to achieve a successful academic learning environment.

Parental Involvement

Parents have the primary responsibility for the education of their children. Winchester Academy serves the parent through Christian advice, love, and support. Our professional educators assist parents by advising them on the best practices for their child's learning and providing programs and events that help them to share in their child's learning. Parents are encouraged to take part in their children's education and to build a strong relationship between the home and school.

Christian Staff

The staff commit to exhibiting Christ-like character and serving as role models for the students and parents. Each has a personal relationship with Jesus Christ and has been called to serve at the school. School Information

Winchester Academy is a subsidiary of Enrichment Services, Inc., a non-profit organization which provides tutoring and enrichment opportunities for children of all ages and developmental needs.

Board of Directors

A Board of Directors governs our school. The purpose of the Board of Directors is to support the school and bring accountability to the administration, parents, and students of Winchester Academy. The current board members and election process are listed on the school website.

History

Our program was co-founded in 2000 by Debra B. Hodgson and Cheryl A. Cintron, area teachers, who desired to bring a quality non-denominational Christian education to the Winchester area. In the first year, Enrichment Services, Inc. opened and began serving area students who needed individualized tutoring. The program served over 100 students ranging in age from Kindergarten to Grade 12. Professional teachers were hired as tutors and students experienced immediate success. To date, over 400 students have been served in a tutoring capacity.

In 2001, the second phase of Enrichment Services, Inc. was developed. Winchester Junior Academy was founded to serve the younger child within the community. A high-quality preschool program was organized to raise the bar for all preschool programs in the area. Small class size, quality education opportunities, foreign language, and computers were all progressive educational experiences for this growing community. This program began with just under 40 students in a small Methodist church in Frederick County. The following year, this program outgrew the church building and an opportunity was available to move to downtown Winchester. This opportunity doubled the growth of the preschool. We were able to offer a summer preschool program, which helped serve working parents. To date, over 500 young children have been served through our preschool and it has developed a reputation among area public and private schools of producing students who are well prepared for any Kindergarten experience.

In 2002, Winchester Academy started our first Kindergarten class with eight students. These students were provided with a developmentally appropriate program that stretched the minds of all children and allowed for creativity along with meeting their individual needs. The success of this small class led to the expansion of our school by increasing to Grade 3 the following year. The philosophy of the school, which allowed for growth and development within a small class setting, reached the community through newspapers and word of mouth. Every year since our opening we have expanded grade levels. Currently, we have 6th grade students and we will welcome 7th grade students in the 2007-2008 school year. Our school continues to make headlines for the incredible academic success of our students, along with fostering the spiritual development of each child.

Accident Insurance

All students are covered by accident insurance, which covers most expenses resulting from the accident. For more information regarding this policy, see an administrator.

Non-Discrimination Policy

This academic institution does not discriminate on the basis of color, race, religion or national origin.

Registration

A registration fee is required to enroll a student each year and is non-refundable

Admissions

School Family enrollment occurs in January of each year. Currently enrolled students will have first priority. Every effort will be made to accommodate the placement of all currently enrolled children during this time. Enrollment forms can only be processed if financial accounts are current. Open enrollment begins the end of January for other students in the community. Openings are limited to the approved classroom ratio. Contact the Director of Admissions for information regarding the admissions process.

All registration information for the following school year will be given out in January of each school year. Children currently enrolled in our preschool will have first priority for placement into the elementary school. The number of classes and age groupings will be determined at the school's discretion.

Winchester Academy has a strong desire to see that young people have an opportunity to receive a Christian education, but at the present stage of development the school is unable to adequately meet the needs of students with the following concerns: Serious emotional or behavioral problems, a physical handicap or other issues that would impair the learning process.

Birth Certificates

Parents of children enrolled after July 1, 1998, are required by Virginia law to provide proof of a child's identity and age. This proof may include a certified copy of the child's birth certificate, notification of birth (hospital, physician, or midwife record), baptismal record, or school record from a public school in Virginia. While not required to keep this proof, documentation of viewing this information within 30 days of initial attendance must be obtained. We cannot keep children in our program for which proof of birth has not been received within 30 days of enrollment.

Medical Records

Every child enrolled in any program in Winchester Academy must have a complete physical exam and have a Medical Health Form on file. These forms need to be filled out and signed by your child's health care provider showing that your child is in good health. The forms also need to indicate up to date immunizations. For children age 2 through school age, the form must be dated within 12 months of admission and updated every time the child has an update to his/her immunizations. School aged children are required to have an updated Medical Health Form upon admission. As with the proof of birth, we cannot keep children in our program for whom a Medical Health Form is not on file. It is the responsibility of the parent to supply an updated form when new immunizations are given and/or health conditions change. Kindergarten students must have updated shots or provide the school with a religious exemption waiver provided by the State of Virginia. Students entering Grade 6 must have the required immunizations. Admission will not be granted without the proper health/medical documentation.

Preschool Age Requirements

To enter the 2 ½ -year-old class, students must be 2 ½ by September 30th. Students applying for the 3-year-old and 4-year-old classes must be the age of their approved class by September 30th. Parents interested in an age waiver, must contact the Admissions Director. The Preschool Administrator must sign off on all age waivers. No child under 2 years of age will be considered for the program.

Preschool Potty Training

It is expected that all children will be potty-trained by 3 ½. We reserve the right to find alternative placement or release the child from the program for a time until the parent begins a potty training program with their child. No discount or reduction in fees will incur during this period. Children who are not potty-trained will not be moved into the four's class.

Parents of children still potty training must include daily in their child's backpack 2 diapers/pull ups/underwear. All students need to have a change of clothes in their backpacks.

Elementary/Middle School Age Requirements

To enter the elementary or middle school, students are expected to turn the approved age by September 30th. Parents who desire to accelerate their child must meet directly with the Elementary/Middle School Administrator. Testing, transcripts, and observations will be reviewed. No child will be accelerated with a birth date past December 31st. The Administrator only approves acceleration.

Waiting Lists

Once a maximum number of students have completed the registration process, a waiting list will be started. The Admissions Director and the administrators will grant acceptance as positions become available. Families offered a position, will be expected to sign a contract within 3 workdays or forfeit the opening. All fees and tuition will be due at this time.

Termination

In the event of expulsion, parents will be provided documentation of the reason for dismissal. Parents remain responsible for tuition up until the date of expulsion. Fees for textbooks, supply fees, and field trip fees are non-refundable.

Withdrawal

Any withdrawal from the Academy must be in writing with 30 days notice before the last date of attendance given. The 30-day notice will be calculated from the date of receipt of the withdrawal letter. A refund or dismissal of tuition will only be considered during this 30-day period and when a replacement has been in the program for 30 days without concern. At this time, notification will be given to families on the wait list. Winchester Academy takes no responsibility for filling vacated positions. Families desiring to withdrawal from the program must stay current on all accounts, until a replacement is found. All delinquent accounts over 30-days will be sent directly to collections. Student records and transcripts will be forwarded to schools after all financial obligations have been satisfied.

Financial Policy

Payment of Fees and Tuition

Families are expected to keep all accounts current. Refer to the Tuition Contract for information regarding your financial commitment. Contact the bookkeeper with specific payment needs. All delinquent accounts over 30 days will be sent directly to collections.

Tax Status

Winchester Academy is a non-stock corporation, incorporated in the Commonwealth of Virginia. The Corporation is organized and operated exclusively for educational and religious purposes as a non-profit organization under the provisions of Section 501c3 or the Internal Revenues Code. Gifts to the school are fully tax-deductible.

Attendance Policy

Attendance at school is an important component in your child's education. The school fosters intellectual development and socialization. Regular attendance enables your child to be successful. However, on occasion absence is necessary. When your child is absent, please call the main office first thing in the morning. It is the parent's responsibility to get the make-up assignments. Awards are given for elementary and middle school Perfect Attendance and near Perfect Attendance (5 days absent) at the end of the school year.

Drop-off/Pick-up

You will be provided with a list of exact times for your child to be dropped off at the building. If you do not come during this time, you must park and bring your child inside to their classroom. For the sake of planning, we would appreciate you following this drop off/pick up schedule. Please do not bring your preschool child any earlier than 8:45 am or your elementary child any earlier than 8:30 am. Staff Members will only be outside during the designated drop-off/pick-up times. DO NOT BLOCK THE DRIVE-THRU WITH YOUR CAR AT ANYTIME. Drop off/Pick up is not a conference time. Please schedule an appointment with the teacher or administrator if you have concerns which need to be addressed. Pickup times are PROMPT. If you are late, you will need to come into the building to the Clubhouse to get your child. You are subject to a \$25 LATE CHARGE per infraction and \$10.00 per fifteen minutes that you are late. No child will leave the building unattended. If an emergency occurs, please call the main office as soon as possible. This system was created to efficiently serve you so that you do not have to wait in long car lines. If you are in line for drop-off or pick-up you will not be turned away or asked to bring your child in school.

We realize that you may be here on time but are sitting in line.

Students leaving before their designated dismissal times must be signed out in the main office by a parent or responsible party designated by the parent with a written note indicating the time they are to leave.

Release of Children

Children will not be dismissed to anyone other than his/her parent unless a written, verifiable note has been received in our main office. Photo ID may be required. Please do not be offended if you are asked to report to the office for verification. This is for your child's safety. It is the parent's responsibility to inform alternate caregivers such as babysitters or grandparents of these essential security procedures.

Tardiness

If you arrive AFTER your designated drop-off time, you will need to come to the main office to sign your child in and then walk your child to class. Tardiness will be documented and included in the child's permanent folder.

School Closing Policy

ALL SNOW DAYS WILL BE ANNOUNCED ON WINC RADIO 92.5 FM Their website is www.winc.fm . We will not follow any school system and will independently close. Private schools are announced AFTER public schools so continue listening

for Winchester Academy. If an early closing is necessary, you will be notified through the radio, email, and by phone. Please pick up your child immediately. Parents may also log on to for www.schoolsout.com, which is a website where delays and closings are posted. For a fee, the website will notify parents of closures and delays via an immediate email and/or cell phone text message

Conduct/Standards of Behavior

The educational program at Winchester Academy involves much more than quality academics. Character development is an integral part of the program. As Christians, we endeavor to live our lives based on biblical standards, which enable us to glorify God. To produce an environment encouraging these goals, our school expects every student to demonstrate by attitude and behavior a life committed to following Christ. "Let no one look down on your youthfulness, but rather in speech, conduct, love faith and purity, show yourself an example of those who believe." (1 Timothy 4:12).

Playground Policy

All students will use playground appropriately. Two playgrounds are provided for the students and are designated by age group. Use of the playgrounds outside of the posted rules will be prohibited.

The following will result in an immediate loss of playground time:

- ✦ Throwing objects such as rocks, chips, snow, ice, and/or debris.
- ✦ Unnecessary roughness and/or fighting, tackling or shoving.
- ✦ Dismantling or vandalizing equipment.
- ✦ Climbing, jumping, or playing on top of fences is prohibited.

Technology Conduct and Safety

Winchester Academy believes in utilizing technology to keep students up-to-date and it is integrated throughout their school day. Because the computers are used daily by students, it is essential to manage and maintain the systems for their use and for their protection. Internet use is essential to the learning of elementary and middle school students. Though the school provides filters, surfing the internet can produce unwanted results that can not always be controlled. Violation of the computer rules will result in disciplinary action. The following rules are in place:

- ✦ Students may use technology resources only when school personnel are present and have given permission and may only use the designated sites allowed by the teacher.
- ✦ Students may not download, install, or store software, or play non-instructional games on a school computer without approval of appropriate school personnel.
- ✦ Students may not change or attempt to alter any configuration, program, or password on any computer system.
- ✦ Students may not use inappropriate language, pictures, or gestures, in any form on the Internet.
- ✦ Students may not use the Internet for unauthorized entertainment, purchases, or illegal activities.
- ✦ When using email, students must not conceal or misrepresent their identity and may not send abusive or offensive messages to anyone.
- ✦ Students must respect the privacy of others and not access the files of others without their permission.
- ✦ There is to be a general respect for all equipment and students should immediately report damage to their teacher.

Preschool students use computers that do not have Internet access.

Lunch Room Rules

- ✦ Students will practice proper conduct and eating habits in the lunchroom.
- ✦ Students will be courteous, respectful, and obedient toward any teacher, parent, or lunch monitor on duty.
- ✦ Students will talk at the lunch table at an acceptable conversational level.
- ✦ Students will remain seated at all times. Permission is needed to use the bathroom.
- ✦ Students will leave my lunch table and floor area neat and clean and will put their garbage in the containers provided.

Classroom/Building Behavior

- ✦ Students must always demonstrate respect for and cooperation with teachers.
- ✦ Students will be on time each day and be prepared with the necessary materials and mental attitude which indicates a readiness to learn.
- ✦ Cheating, stealing, lying, and plagiarism will not be allowed.
- ✦ Students are responsible for the cleanliness around their desks at the end of the day.
- ✦ Students are expected to walk in hallways and between buildings; no running. Talking should be at a normal voice level.
- ✦ All students should do their part by keeping classrooms, halls, walkways, restrooms and lunchrooms free of litter. If you see a problem, take care of it or report to a teacher.
- ✦ Chapel is a time set aside for praise, worship, and instruction from the Bible. Students enter and leave chapel in a manner conducive to worship.
- ✦ Students will not be involved in immoral activity.
- ✦ Students will not swear, tell inappropriate stories or jokes, or use profanity or any language that is unbecoming to a Christian.

Discipline Policy

When a child feels good about him/herself and about others, he/she is able to develop inner discipline and control. Discipline helps the child to acquire those skills which are needed to function effectively in the world; courtesy, an attitude of caring about others, respecting the feelings of others, appreciating the world God made, establishing self-control, and most importantly knowing they are a child of God and loved very much.

“My son, do not despise the LORD's discipline and do not resent his rebuke, because the LORD disciplines those he loves...
“Hebrews 12:5-6

Winchester Academy has a firm commitment to using a positive approach to discipline. This approach follows the philosophy of Conscious Discipline by Dr. Becky Bailey. This information is found on her website. http://www.beckybailey.com/conscious_discipline.cfm. This approach dramatically reduces the need for staff to use disciplinary methods.

No child will be allowed to hurt others or to destroy property. The staff will intervene and an appropriate consequence will be given to reinforce to the child that the behavior is unacceptable. When a child consistently displays behavior that is disruptive to the continuity of the program or hurts other children, the following steps will be implemented as needed:

- ✦ The teacher/administrator will discuss the behavior with the child and help them to make retribution.
- ✦ The administrator will discuss the behavior with the child and the parent will be notified by means of a letter, phone call, or conference that a serious behavior problem is occurring on a regular basis and a behavioral plan will be implemented.
- ✦ The teacher will keep a log of ongoing behavior problems and notify the administrator of any concerns.
- ✦ The administrator will hold a conference with the parent and the teacher to discuss a realistic course of action and to determine a time limit for improved behavior.
- ✦ The administrator will hold a conference with the parent to discuss the child's continued enrollment at the school.
- ✦ In the event of extreme behavior, the school administrator has the right to immediately suspend or dismiss the child.

The following actions or threats on the part of a staff member are forbidden:

- ✦ Physical punishment, striking a child, roughly handling or shaking a child, restricting movement through binding or tying, forcing a child to assume an uncomfortable position, or exercise as punishment.
- ✦ Enclosure in a small confined space or any space that the child cannot freely exit himself; however, this does not apply to the use of equipment such as cribs, play yards, high chairs, and safety gates when used with children preschool age or younger for their intended purpose.
- ✦ Punishment by another child.
- ✦ Separation from the group so that the child is away from the hearing and vision of staff member.
- ✦ Withholding or forcing of food or rest.
- ✦ Verbal remarks, which are demeaning to the child.
- ✦ Punishment for toileting accidents.
- ✦ Punishment by applying unpleasant or harmful substances.
- ✦ Punishment by repetitive writing.
- ✦ Punishment through verbally abusive language.

Middle School Discipline Policy

All students are expected to uphold the high standards of our school. Respect to self, peers, and authority are a top priority. When a middle school student is not displaying appropriate behavior the following discipline plan is in place:

First incident is a warning, second incident is a lunch detention, and a third incident is a detention with the teacher. A fourth incident is a required meeting with the administrator. The parent will be contacted upon the second incident and all incidents that follow. Parent/teacher/administrator communication is essential.

Harassment Policy

Winchester Academy's goal is to provide an atmosphere that is free from harassment (whether based on gender, race, color national or ethnic origin, age, or disability) an environment that is free from all forms of intimidation, exploitation, and harassment (including sexual harassment), where all individuals treat each other with dignity and respect. The school includes bullying in its definition of harassment. The school is prepared to take action to prevent and correct any violations of this policy. This policy applies to the actions of administration, teachers, staff, parents, volunteers, and students. Anyone who violates this policy will be subject to discipline, up to and including termination or expulsion.

Tolerance Policy

Tolerance is a virtue. Tolerance refers to the Christian ideal of accepting one another without passing judgment in areas that are non-essential to salvation. This policy seeks to draw some boundaries with regard to our interaction with the popular culture. We encourage parents to be tolerant of other families' views on what cultural material they deem appropriate on their own time. However, at the school, there are certain limits.

Our goal as a Christian school is to provide opportunities for children to have spiritual, emotional, and academic growth. However, we are sensitive to parents being concerned about "fantasy" material such as games and trading cards that can be perceived as something "dark" or inappropriate to the academic and social environment we strive to maintain.

We will not promote literature that outwardly promotes pagan/gothic views. Vocabulary that is profane or games of pagan/gothic worldview, particularly with violent content, will not be allowed. When teaching about other countries our children will learn about pagan beliefs and other religions. Tolerance and love will be taught when describing other faith organizations/groups.

Children will be taught tolerance regarding these questionable games/information. No child will be made to feel that they have committed a crime for enjoying/speaking of these games and teachers will not engage in their own opinion regarding these fad cards, games, and literature. Children are allowed to report on these topics of interest. However, parties, clubs, and activities within our school will not promote this questionable material.

The school takes no position in relationship to parents' personal faith issues. Winchester Academy is a non-denominational program that promotes tolerance and love. As a resource to parents, a Clergy Director is available to discuss their issues or their child's spiritual development. With regards to children who are asking specific questions in relationship to Christ, the Clergy Director may be called upon to help guide the parents on the best way to handle this spiritual moment.

Onsite School Policies

Snack/Lunch Time

Preschool

The parents will rotate providing snack for the class each day. Teachers are responsible for arranging snack schedules. Please contact your child's teacher if you have any questions. Parents who have children with particular food allergies will be asked to not participate in the class rotation and must send in their own snack each day. Be sure to send ENOUGH food for each child. We ask that the snack be nutritious and to save sweets for special times and birthdays.

If your child is ill on the day he/she has snack, please call the school immediately, so the teacher can make arrangements for a replacement food item. Please send a replacement snack with your child when they return. If you forget snack on your child's snack day, you will be billed \$10. All snacks must be cut, peeled, prepared, etc. and packed in individual serving portions. Drinks must be juice boxes/pouches ONLY.

After the children have become acclimated to the new school year, we encourage parents to come in on their child's snack day as an extra special treat to the children.

Ideas for Snacks: apples, bananas, strawberries, grapes, fresh vegetables and dip, cookies, graham crackers, pretzels, popcorn (individual bags), peanut butter & jelly sandwiches for ages 3 and older, cheese & crackers, snack crackers, fruit snacks (individual packages), applesauce/pudding, rice krispy treats.

Ideas for Drinks: apple juice, white grape juice and lemonade.

New ideas are great! These are just a few that the children seem to enjoy. Prepare enough for the entire class of hungry students, unless otherwise stated by your child's teacher.

Note: In consideration for students with food allergies please send in alternative snacks/sweets for special occasions such as birthdays, holiday parties, etc., so these students are not left out of the special treat.

Grade K-5

All children will be allowed to bring in one food item and a drink for the mid-morning snack. We encourage all parents to pack nutritional snacks and lunches. Please pack your child with the appropriate utensils, napkins, etc. needed for their snack/lunch. Catered lunch options will also be available at the parent's expense. Please only pack cold lunch items for Kindergarten and Grade 1, as your child cannot be solely responsible for using a microwave. There are very few microwaves and your child's lunchtime is limited.

If a lunch is not provided by the parent a lunch will be given to your child and a Lunch Charge Slip will be sent home. You will be charged on your next invoice.

Grade 6 and 7

Middle school students have a designated lunchtime and breaks throughout the day, which may be used for opportunities such as eating, catching up on schoolwork, and reading. No formal snack time is provided.

Field Trips

On occasion we will take field trips. Any child taking a field trip must be restrained in a car seat/booster seat, unless they have reached age six where a regular seat belt is adequate. We do ask for parent volunteers as drivers for our field trips, but you **MUST** be able to fit car seats/boosters in your vehicle. We encourage moms, dads, grandparents, etc. to assist with field trips.

In an effort to keep the students together and safe during a field trip, please dress your child in the elementary burgundy logo shirt or the light blue middle school shirt. Preschool students will wear the appropriate clothing for the trip.

PLEASE NOTE: Due to safety factors, we ask that you not bring siblings. There will be times when siblings will be welcome. When a permission slip is sent home, please return it as soon as possible.

When children are transported on field trips, all drivers of motor vehicles (teachers or parents) must provide proof of a valid Virginia Drivers License. If a vehicle is used that transports 16 or more children, that driver is required to present a Virginia Commercial Driver's License. All vehicles used by Winchester Academy to transport children must provide insurance information that will include bodily liability insurance and property damage insurance. Staff members as well as parents must provide this information to the administration before they will be allowed to transport children.

Health Policy

Your child's health is a matter of major importance to all of us. For this reason, Winchester Academy has established a strict health policy. Upon the child's arrival to school each day, a staff member will briefly observe the child for obvious signs of illness. A staff person is on duty at all times who has been trained in daily health observation.

Winchester Academy defines a sick child as one who has any of the following symptoms:

- ✦ A temperature of 100 degrees or more within the past 24 hours.
- ✦ A thick, yellowish-green runny nose accompanied by a fever or a cough.
- ✦ Nausea, vomiting, or diarrhea within the past 24 hours.
- ✦ An undiagnosed and/or contagious skin disease.
- ✦ Symptoms of possible communicable disease. (Please notify the school at once if your child has a communicable disease).
- ✦ A highly contagious condition, such as pink eye or lice.

The parent should not bring his/her child to school if any of the above conditions were present the night before. We reserve the right to refuse admission to any child with the above symptoms. If a child becomes ill during the school day, parents will be notified immediately. Pick-up arrangements must be made upon notification. For this reason, it is **IMPERATIVE** that emergency numbers are current and up-to-date. From time-to-time the administration may feel that your child is displaying curious signs of illness. Winchester Academy reserves the right to ask for a doctor's note stating that the child has been seen by a physician and they are aware of the health concerns and are working to improve the child's overall health.

Medications Policy

No medication should be transported through the backpacks. All medication should be dropped off and picked up at the front desk as necessary. Expired medications will be disposed of on the expiration date. Parents of students who require long-term medications will be notified if the medication expires. No medication will be administered past the expiration date.

Short-Term Prescriptions and Over-the-Counter Medication

The school will administer medications as long as the medication is in a properly labeled prescription bottle. The prescription bottle, a measuring dispenser, and the Medication Release Form, located on the Winchester Academy website, need to be located inside a Ziploc bag with the child's name.

Long-Term Medications

Any medication to be administered longer than ten days must have a completed Medical Release Form, with a doctor's signature.

Child Abuse Policy

All staff members are required by the code of Virginia Section 63.1-248.3 to report any suspected child abuse or allegation of neglect.

Middle School Clothing/Dress Code

All students are required to wear their school uniform and abide by the dress code. All middle school students are required to have one light blue button down oxford with the mascot logo purchased through Educational Outfitters. Also, a raincoat or hooded coat is required. Umbrellas will not be permitted. Other items may be purchased at other locations. The following dress code applies to all middle school students:

- ✚ Brown or black shoes and sandals
- ✚ Light blue button down oxford shirt with mascot logo, ties are optional and any Lands End tie within our colors is acceptable
- ✚ White, navy blue, hunter green, navy or burgundy* oxford or collared shirts with or without logo
- ✚ White, navy blue, hunter green or burgundy* sweaters or vests with or without logo

Girls:

- ✚ Navy blue, khaki and plaid**skirts, shorts, skorts, pants or jumpers
- ✚ Brown, black, white, navy blue shoes and sandals
- ✚ Light blue button down oxford shirt with mascot logo
- ✚ White, navy blue, hunter green, navy or burgundy* oxford or collared shirts with or without logo

Elementary Clothing/Dress Code

All students are required to wear their school uniform and abide by the dress code. All students are required to have at least one burgundy shirt and one gray logo shirt. Also, a raincoat or hooded coat is required. Umbrellas will not be permitted. Other items may be purchased at other companies. The following dress code applies to all elementary students:

- ✚ Navy blue and khaki pants and shorts
- ✚ Brown or black shoes and sandals
- ✚ Burgundy* logo long and short sleeve shirt
- ✚ White, navy blue, or hunter green short and long sleeve collared shirts/sweaters with our without logos

Girls:

- ✚ Navy blue, khaki, or plaid** skirts, shorts, skorts, pants and jumpers
- ✚ Brown, black, white, navy blue, or burgundy* Mary Jane style shoes and/or sandals- No heels
- ✚ Burgundy* logo long and short sleeve shirt
- ✚ White, navy blue, hunter green and burgundy* short and long sleeve regular or peter pan collared shirts

PE:

- ✦ White/navy blue athletic shoes
- ✦ Grey* logo T-shirt, short or long sleeve
- ✦ Navy blue sweat pants, sweat shirt, or zip up sweat shirt
- ✦ Navy blue shorts
- ✦ White socks

Preschool Clothing/Dress Code

Remember that many varied activities are conducted each day; including painting (washable, of course), so play clothes and tennis shoes are recommended. A raincoat or hooded coat is required. Umbrellas will not be permitted. Clothing that is not appropriate at the preschool: sunglasses, jewelry, short skirts, midriff shirts, and T-shirts with inappropriate pictures and sayings. We take no responsibility for damage to clothing. Remember: learning should be fun, expect clothing accidents!

Personal Appearance

All students should be properly groomed and take pride in their personal appearance. Tattoos must be covered during school hours and school functions; jewelry for piercing must be removed, except for earrings for young ladies. Clothing should fit appropriately and be free from holes and markings. Hair should be maintained in a way that does not interfere with the learning process.

Personal Property Policy

We ask that you **do not** allow your child to bring toys, electronics, cell phones into the classroom unless requested. If an item is brought to school, we cannot be responsible for it. At no time will war toys, guns, knives or other violent weapons or figurines be permitted. No trading game cards are allowed in our program because they are disruptive for learning. See a teacher/school representative for questionable material. Items brought to school during the regular school day will be confiscated. Parents must pick up the item from the appropriate administrator. Items inappropriate for the classroom are also inappropriate for Show and Tell.

The following items are appropriate only during Clubhouse and Parent's Night Out and are the responsibility of the child and parent. The times of use may be restricted.

- ✦ Sports cards, which are not game cards, will be allowed. However, no trading will be allowed.
- ✦ Handheld video games and other electronic games will be allowed. Only games rated E for EVERYONE are permitted. Linking of gaming systems can be done.
- ✦ Computer games rated E for EVERYONE and music with a general rating will be allowed. Headphones can be shared.

Outside/Cold Weather Policy

Students will be outside daily as weather permits. Students will not go outside for recess on rainy days or when temperatures are below freezing. It is required that all children have appropriate coats, hats, and gloves. No child will be allowed to skip recess due to health issues unless a doctor's note is provided.

Classroom Parties, Birthdays and Observed Holidays

Valentines Day, Easter, Thanksgiving and Christmas will be treated as Christian holidays. Halloween will not be observed. Classroom parties for Valentines, Easter and Christmas will be organized by the room-parents/PTF. A school wide Thanksgiving celebration will be held.

Birthday celebrations in class will be limited to cupcake/snacks being brought in at snack time. Due to the time frame of lunch we will not be able to have these snacks brought in at lunch time.

Individual party invitations may be given to the teacher to place in travel folders only if all students are invited. This will avoid any hurt feelings. If all children are not being invited please mail the invitations or find some other way of delivery.

Lost and Found

When articles are found anywhere on campus they are turned in to the Lost and Found in the main office. They will be returned to their owner, upon verification. All items not claimed or identified, will be donated to a charity. Please write your child's name on lunch boxes and outerwear to help us send them back home.

Damage to School Property

Any deliberate or careless damage to school properties will need to be paid for by the student causing the damage.

Middle School Lockers

All middle school students will be issued a locker and will be expected to keep his/her locker clean. All books, lunches and other personal items are to be kept in their locker. All students will be responsible for the locker combinations and they are not to share lockers or store items in other areas without discussing them with the homeroom teacher. Their combination is something that they should keep private between themselves and their teacher. Lockers are the property of Winchester Academy and may be searched at any time without notice.

Middle School between Classes

Middle School students will be given the privileges walking to and from classes without an escort. Teachers will remain on duty and observing student behavior and to ensure a safe arrival to the next building or classroom. Students who are late to class could lose their travel privileges and the parents will be notified. Students will be disciplined when repeatedly tardy to class.

Academic Policy

Honor Code Policy

Students at Winchester Academy are held to the highest level of moral standing. Students will not lie, cheat, steal, or plagiarize. Students found in violation of this code will be disciplined appropriately by the administration. As Christians, we should do all things for the glory of God (1 Corinthians 10:31).

Elementary School Honor Code

Elementary students are required to sign a pledge at the beginning of the school year that indicates their commitment to and understanding of the Honor Code.

Middle School Honor Code

Middle school students are required to sign the Honor Pledge when presented on all quizzes, tests and other work done for credit. In so doing, students give their word that their work is their own.

"I pledge on my honor that I have neither given nor received unauthorized aide on this assignment."

Assignment Books

Each student in grades 2 and up will be issued a school assignment book. Parents are expected to review the assignment book nightly. Comments and concerns by both teacher and parents should be noted in this book or emailed.

Homework Policy

Our staff believes that the family unit is very important. Academic time is used wisely at our school allowing students the opportunity to engage in other activities not related to the school. Therefore, we have a limited homework expectation for students.

Specific homework is given to students for remediation purposes. Other homework including weekends may include studying for tests, assigned reading, and projects.

Accelerated courses in middle school may require additional homework up to 3 nights per week in order to accomplish course objectives.

Grading Policy

A report card will be sent to the parents of each student at the end of each nine-week grading period. It will indicate the child's progress in the different disciplines and the development of attitudes, work habits, and social behaviors. Preschool students will receive an evaluation at the end of the first semester and then end of the school year.

If Interim reports are necessary, they will be sent home during the first 4 or 5 weeks of each quarter. Parents should seek a Parent/Teacher Conference when such a report is not satisfactory. Mandatory Parent/Teacher Conferences are scheduled at the end of the first and third marking periods. Preschool parents are asked to conference at the end of the semester to discuss their child's progress.

Students in Kindergarten and Grade 1 are given reports that focus on mastery (M), progression (P) and needs help (NH). Final academic grades of A-F are given at the end of the year to students in Grades 2 through 7. All grades are part of the permanent record. Below is the school grading scale:

The final report card grade given at the end of the school year is averaged using the following point system:

In grades K-5 the teacher is obligated to average the points that the students accumulated for each of the four quarters in order to determine the final grade.

In grades 6-8 to teacher averages the points at both semesters and takes the average of the two semesters for the final grade.

All points coming out to a decimal of a .5 and up will be rounded up to the higher letter grade.

Academic Difficulties

Teachers will use a variety of teaching strategies. In relationship to grades, if the student has failed a test, the teacher has two options: retest and average the grades together or retest and take the higher of the two grades. Some teachers will use extra credit as an option that can be in the form of a project and used as a replacement for another test. Extra credit points can be used to increase the grade of a test or assignment. It is the student's responsibility to make sure that these projects are turned in on time.

A teacher or a parent may refer a student to the Enrichment Services director if he/she feels that individual tutoring would be beneficial. The Enrichment Services Director will assist in an academic plan for the student. This service is an additional cost to the parents.

Honor Roll

This recognition is available to students in Grades 2 through 7. Students who receive all A's on their report cards qualify for A Honor Roll recognition at the end of the quarter. There cannot be any grades lower than an A on the report card in any class, including electives.

Students who receive A's and B's on their report cards qualify for A/B Honor Roll recognition at the end of the quarter. One C is allowed on the report card, but it must be balanced with an A in an academic (core) class (Math, Science, Social Studies, and Language Arts).

All students who receive Honor Roll will have their names posted on a bulletin board in Building II under HONOR ROLL STUDENTS. Students on the A Honor Roll will have their names sent to the Winchester Star to be posted in the newspaper.

{Winchester Academy does not take responsibility for misprints or names left off the list by the Winchester Star. This is a free service and the Winchester Star reserves the right to not print the honor roll list.}

Students who have received Honor Roll for four quarters will be given a special certificate included in their awards packet that states they have received Honor Roll for the entire year. Teachers value this as a great accomplishment and emphasize its meaning to the students. Middle school students will also receive a chenille letter for A and A/B honor roll.

Standardized Testing

Assessments of academic growth are an ongoing process at Winchester Academy. Each spring, students in Grades elementary and middle school will be administered a standardized achievement test to provide information on the academic growth that took place during the school year. Results are forwarded to parents in the following summer. Transferring students will have their results sent to the appropriate school system. These scores in no way affect a child's evaluation by the teacher or the grading on the report card. In addition, the scores do not determine a student's promotion or retention.

Academic Competitions

To further enhance the curriculum, we are excited for our students to be given the opportunity to advance beyond our school. Academic competitions are done within the school, with other private and public schools, and organizations both local and national.

Library Policies

The library is available for students in elementary and middle school, teachers, and families of Winchester Academy. All books can be checked out for one week and renewed up to three weeks. Media such as CD's, DVD's, VHS etc., must be returned after 1 week. If the item is not on a waiting list then the item can be renewed. Students in Grades K through 3 may check out one book at a time. Students in Grades 4 through 7 can check out two books at a time. Students who do not return checked out items, will be subject to fees and are not permitted to check out additional items until the fees have been paid.

Literature Selections

Winchester Academy believes that each child should be exposed to different forms of literature. Though we promote classic literature, at times, the language can be difficult to understand or could have profanities. The school takes the following position regarding Classic literature:

- ✦ Classic literature containing profanities text will be allowed, but teachers are instructed to explain the vocabulary and its reasons for usage.
- ✦ Children will be allowed to read books of fantasy that have been brought from home.
- ✦ When the school is purchasing books, Winchester Academy reserves the right to approve books on a case-by-case basis as long as they are not on the controversial list located in the office.
- ✦ When accepting donated books, the librarian will read the book and fill out a questionnaire.

If there is a concern regarding questionable material within our school library, the material will be placed in the Administrator's office until a teacher, Parent Director, and committee members have had a chance to meet and discuss the questionable material. At that point the committee will determine whether or not the material should be allowed to remain at the school. If it is allowed to remain at the school a notation will be made in the Questionable Material File for parents and community members to look at upon request. A letter will be sent to the person making the allegation to inform them of the committee's decision. This person can appeal the decision of the committee directly to the Board of Directors through a written letter. The Questionable Material Committee includes: one Administrator, one Teacher, the Librarian, and one Parent Director.

Instruction

Students are placed in age-appropriate classes. Our low teacher to student ratios, provide the student with individual attention and small group experiences.

Curriculum

Educating our children is the priority of our program. We take care in ensuring that your child is academically, socially, and emotionally growing within the classroom setting. Hands-on lesson plans are prioritized to meet all learning levels. If you have specific questions about the curriculum used in the middle school, elementary school, or the preschool, please contact the Curriculum Administrator.

Preschool Curriculum: Each month the preschool classes work from a specific theme. Teachers will follow goals and objectives appropriate for their age group. They will choose activities that best help the preschool students meet these goals. Weekly communication will be sent by email to keep parents up-to-date on school activities. Two-year-old classes receive music and chapel and Three- and Four-year-old classes receive music, chapel and foreign language.

The following is a sample preschool schedule. Children will have the opportunity for computer learning, language development, hands-on science, math activities, foreign language, ethics, large/small motor skill activities, and art/music appreciation when developmentally appropriate. Note: The times of activities will vary depending on available building space. This example is from a Four-year-old teacher's schedule.

Elementary/Middle School Curriculum: Teachers follow the Standards of Learning from the State of Virginia. These are considered the minimum requirements for our students, however, the expectation for achievement is to rise above these minimum requirements and focus on the higher levels of learning. Weekly communication will be sent by email to keep parents up-to-date on school activities. Elementary students receive instruction in language, math, science, social studies, bible, art, physical education, music and foreign language.

Middle School Electives - We believe that a well-rounded student will become a well-rounded citizen. A variety of experiences in a variety of subject areas will be made available throughout the year in the form of electives (during school) and clubs (held after school). Middle School students are required to participate in elective courses.

Middle School Community Service Requirement - We believe that one of the components of being a strong Christian is to serve in the community. As a required component of middle school, nine hours of confirmed community service is expected each quarter of the school year (approximately one hour per week). Each student will complete a Work Plan at the beginning of each quarter and be required to turn in a Confirmation of Hours form at the end of each quarter. A variety of experiences are encouraged and suggestions are provided, however, the plan and execution are the sole responsibility of the student. Parental involvement is expected.

Middle School Student Council Opportunity - As part of our leadership training at Winchester Academy, students are provided with the opportunity to serve in student government. These leaders will assist in planning school activities, communicate with school leadership, promote school spirit, convey Christian values and give overall leadership to the school community.

Members of the student government will be elected. There will be a president, secretary, and treasurer and all students will be members of the government. They will meet weekly. The duties of these positions will be given to the students and fundraising opportunities will be discussed to help students raise money for their class trip.

Extra-curricular Activities

Parents Night Out (PNO)

This program is offered to all parents and their guests on Friday or Saturday evenings from 6 pm until 10 pm during the school year. A calendar will be provided monthly. The cost of the program is \$5.00 per hour for 1 child, \$8.00 per hour for 2 children, \$10.00 per hour for 3+ children. The proceeds from this program directly benefit the sponsoring teacher's classroom budget.

All children attending must follow the rules outlines in this handbook that evening.

Enrichment Services, Inc.

Enrichment Services is designed to assist every student, making learning much easier, more fun, and more rewarding. Programs include enrichment, challenging programs, and curriculum for students ready to move ahead, tutoring for students needing assistance in a specific subject, and SAT preparation

Enrichment Hours

Periodically special, age-appropriate programs will be offered to all students in our school. These programs are an additional cost to the parent and are provided to enhance outside interests. Participation is at the discretion of the parent. Students participating in the Enrichment Hours must adhere to the standards of behavior for Winchester Academy.

Tutoring

Individual tutoring is available for any student in any subject, from pre-reading to advanced-placement math. There is also ESL and adult tutoring, along with organizational skills for all age groups. The tutors work closely with your child's teacher to maintain consistency. Long and short-term contracts are available to meet all of your child's educational needs.

Clubhouse Policy

Care is offered Monday through Friday before school from 7:45 am to 8:45 am and after school from 12:00 pm to 5:15 pm.

Drop-off/Pick-up

In the morning you must park and bring your child into the building, and pick them up from the designated Clubhouse room in the afternoon. Signing in/out is required for all persons that are not the child's parents.

Late Pick Up

In the case that the child is picked up after closing time, there is a \$25 LATE CHARGE, which will be assessed plus you will be charged \$10.00 per fifteen minutes that you are late.

Preschool Clubhouse Lunch Time

Parents will provide lunch for their child(ren). Lunch needs to include a drink and any utensils they may need to eat their lunch. Please send a cold lunch. Catered lunches are available for interested parents.

Preschool Clubhouse Nap Time

Parents should provide a pillow for nap time (optional), and a blanket. The pillow and blanket may be kept at school but must be brought home weekly for washing. If there is an item that your child is attached to especially for nap time, please send that also. All students are to rest for the required 30 minutes; however, napping students may rest for up to 2 hours.

There is a fee of \$10 for a cot sheet for preschool students.

Enrollment for Clubhouse

If you are interested in enrolling your child in the Clubhouse you will need to contact the Director of Admissions.

Communication/Parent Policy

Website

Winchester Academy has taken the time to develop a web based communication system for parents. With changing emails and schedules that are outside operating hours, a web based system is a convenient mode of communication. All school information that you need is at your finger-tips 24 hours a day. Hopefully this will accommodate everyone's busy schedules. Each teacher has a page on the website for individual classroom notes; the PTF has a page as, does the administration. Mass emails will only be used in cases of emergency. Parents are encouraged to email their child's teacher directly if they have any questions. All attachments sent by Winchester Academy will be sent as a Word document or as a .PDF file.

Teachers will continue to use the folders in the backpacks as a method of communication with parents and they will also email individual parents with concerns or questions.

Winchester Academy reserves the right to update and make improvements to the web based systems that they use.

Parent Involvement/Fundraising Policy

Parental involvement in the school is an important part of Winchester Academy. It is a great opportunity to get to know the teaching staff and other families that value Christian education. It provides fellowship among families as we work together on a project or an event. As we are involved together, we have the privilege of serving the Lord, building friendships, helping Winchester Academy, and being a positive example to our children.

Parents Responsibility

What you can do to Help Your Child Learn

- ✦ Pray with your child often.
- ✦ Start each day right: a calm beginning at home makes the school day much better. Gather school things the night before.
- ✦ Encourage your child to have a good breakfast and lunch. Make certain that your child sleeps at least eight to ten hours each night.
- ✦ Praise your child each day for something he/she has done. Have a special place to put school work or what is brought home.
- ✦ Laugh and talk with your child about school experiences and listen attentively to what is said about your child's school day experiences.
- ✦ Stress attendance. If the child is ill, home is the best place; otherwise, your child needs to take advantage of every school day.
- ✦ Keep the lines of communication open between yourself and your child's teacher. Inform the teacher of any family situation which could influence your child's behavior. Also, if he/she is reluctant to go to school, let the teacher know so that together you can find the reason.
- ✦ Take your child to the library and encourage reading for pleasure.
- ✦ Stress the organization of notebooks, desks and materials, etc.
- ✦ Set aside a specific time and location for homework, test review and projects.
- ✦ Check the website weekly for news from teachers and administration.

PTF

The PTF was designed to support the school and help with efforts to bridge the gap between teachers/administration and parents. We need volunteers to serve and help grow this program. It is open to all preschool, elementary school, and middle school parents. This organization oversees specific programs such as recognition for moms and dads, teacher appreciation/recognition, teacher gifts and school gifts, etc. There are a few scheduled meetings throughout the year and we ask that you consider taking a leadership role.

Winchester Academy requests that every family try to give 20 hours of volunteer time during the school year or donate \$12.50 per hour (\$250 per year) to the PTF. A variety of opportunities will be presented at the beginning of the school year and during the school year from which families may choose. Of course, the students and staff always benefit from additional time and/or money that are donated.

One parent from each family is required to serve on or lead a committee for activities held by the school or the PTF. A list of committees will be provided by the PTF prior to the beginning of the school year for your review. There are a variety of choices that should fit everyone's life schedule. If no decision is made, you will be placed on a committee based on our schools need.

Business Partner

The PTF will have a listing on the website and on the bulletin board for families with businesses that are willing to donate a percentage of their sales or a set figure from sales where other Winchester Academy families are involved. Contact should be made directly with the PTF if anyone is interested.

Donations

Winchester Academy/Enrichment Services is a non-profit 501(c)3 organization. We gladly accept donations. If you have items you would like to donate or a monetary gift, please see the bookkeeper where a receipt will be written for you upon request.

Fundraising

All families will be asked to participate in Winchester Academy's Annual Children's Art Exhibit and Auction. We request 100% participation from parents to help us meet our yearly budget. Participation can be in various forms including but not limited to assisting on the committee, donating items for the auction, or attending the auction. On occasion, we have fundraisers to raise money for specific items/events. Participation in these smaller fundraisers is optional.

The PTF will have different fundraising opportunities through out the year, which are also optional. These funds are used to support the scheduled PTF events, activities and teacher recognitions.

Volunteerism/Visitation

All parents are welcome to visit our school and we welcome their help. We need parents help to make our programs exceptional. Parents are asked to volunteer as often as they would like with schedules pre-arranged with the teacher or administrators. All visitors/helpers, upon their arrival, must go directly to the main office to receive a badge/key. However, teacher/student instruction time must not be interrupted with unexpected visitors. If you are volunteering for your child's teacher you should not bring younger children/siblings.

Please note: If your presence in your child's classroom is not conducive to your child's progress then you will be asked to volunteer in other ways. We must do what is right for the children and sometimes that means sacrificing our personal desires.

Volunteers are not to be left alone with students at any time. Substitutes, Teaching Assistants and tutors will have a criminal background check and Virginia State Police Criminal History Record/Sex Offender and Crimes Against Minors Registry Search and Child Protective Services Central Registry Search.

We ask that volunteers follow the school dress code and conduct policy.

Room Parents

Every classroom will have a Room Parent Representative that will serve as the "Room Parent" who will organize parties, classroom volunteers, and special teacher needs. In middle school, student delegates will fill the position of Class Representative.

After the school year begins, a room parent for each class will be chosen by the PTF. Duties include: planning parties, helping with or arranging transportation for field trips, and assisting with any special projects within the classroom as requested by the teacher.

Emergency Policy

Emergency Preparedness Plan

A plan will be provided to all parents at the beginning of the school year. Emergency plans are located in every classroom and additional locations throughout the buildings. In the event of a school evacuation, students will be taken to either Quarles Elementary School or South End Fire Hall. An announcement of the location will be made on the radio at 92.5 WINC FM.

Fire Alarms

All emergency procedures are located in the administrator's office and will be made available for review upon request. Monthly fire drills are conducted and yearly inspections are done with the Winchester Fire and Rescue.

Grievance Policy

From time to time, disagreements may arise between students and/or parents and school personnel. The principles for resolving such matters are described in Matthew 18:15-17. Specially, if a legitimate disagreement with a teacher arises, parents should seek first, with all respect and Christian love, to resolve the problem with that teacher. With good communication from everyone, it is likely that most problems can be resolved at this level.

If resolution cannot be reached, then the student/parent should meet with the teacher and the administrators. Parents should not expect the next higher in authority to listen to criticisms of the teacher without the teacher having the opportunity to be present. The administrators will make a final resolution decision. The chief administrator makes the final decision for all school policies, including discipline. The Board will only hear appeals in cases where school policy is violated.

Conciliation Agreement

In the event that conciliation is necessary (after all efforts by the administrators and board of Winchester Academy fail to resolve the dispute), the Rules for Procedure of Christian Conciliation established by the Association of Christian Conciliation Services shall be the sole remedy utilized in pursuing arbitration/mediation. Because Winchester Academy is a ministry, we rely on the Bible as the inspired Word of God as our ultimate source of instruction for the principles, which guide this school.

One of the principles clearly set forth in Scripture is the instruction that believes are not to sue on another in public courts. Grievances between believes are to be settled within the Body of Christ. (See 1 Corinthians 6:1-9 and Matthew 18:15-20)

School Support

The staff and administration are very interested in helping to resolve any issue that may arise; however, we need parent assistance to reach that goal. Please contact an employee with questions or concerns so a quick resolution can be found. Our goal is to let our light shine to the community of always honoring each other in word and in deed. It is expected that students, parents, and school staff shall always show respect in every way to each other in obedience to the admonition of our Lord (Ephesians 4:29-32).
